* A value of 99 (not applicable) for the first call to ASHA does not seem correct as the respondent has yet to receive any test results. It is possible that “not applicable” was the default value for these variables which did not get updated with the result of the call. Three of the cases with a 99 value for the first call are the cases that have flags indicating two calls were recorded at the exact same date and time. For calls made after the respondent received the test results, a “not applicable” value could indicate that the respondent called back to confirm a referral or other piece of information.
